# Wales National Workforce and Reporting System (WNWRS)

#### **Data Extract 30 September 2022**

Thank you to all Practices who have validated and updated their data on the WNWRS prior to the next data extract on 30/09/2022. If you haven't already, please visit the WNWRS site:

and check the staff records for your Practice are an accurate reflection of your workforce. To validate your Practice details you just need to log into the site – there is no need to send us anything.

If you have taken on any additional staff or if existing staff are working extra hours, please reflect this in their staff record. If existing staff are working extra hours, please keep their contracted hours the same, but increase their working hours to include the extra hours they've worked on average during the Quarter.

## **Certificate of Sponsorship**

Last month we highlighted the new support and reimbursement of funds announced for GP Practices should they wish to become Sponsors for newly qualified GPs needing a Certificate of Sponsorship to work in Wales. We are pleased to see several Practices taking up this offer and have applied to become sponsors, thereby opening up another route to recruit GPs to their Practices.

If you are a Practice who applied for re-imbursement for costs incurred when applying for a Sponsorship licence, please ensure that you enter the details of the individual you are sponsoring in the WNWRS as soon as possible, to ensure prompt re-imbursement of any incurred fees. The data in the WNWRS is used to validate any application for reimbursement.

## **Locum Indemnity**

Please be aware that access to General Medical Practice Indemnity (GMPI) is different for substantive staff and Locum GPs.

For substantive staff, their access to GMPI is via entry on the WNWRS.

For Locum GPs, they should be included on the MPL, the All Wales Locum Register (AWLR) and record all their shifts worked on Locum Hub Wales (GP Wales).
