Following the communication issued regarding the updated Guidelines for the Scheme for General Medical Practice Indemnity (GMPI) we have received some questions around the changes – please see the FAQs below.

If you have any queries which are not addressed below please contact us for further assistance.

Q. Do locum GPs have access to indemnity under the discretionary Scheme for GMPI for all shifts worked before the 8 December 2020?

A. The GMPI position for shifts worked before 8 December 2020 is as per the previous Guidelines - i.e. all Locum GPs undertaking Locum work in Wales need to be on the All Wales Locum Register (AWLR) and if registered on the AWLR then shifts are eligible for the discretionary scheme for GMPI.

Q. Do we need to enter External Shifts (shifts booked outside of LHW) from before the 8thDecember 2020 to have access to indemnity under the discretionary Scheme for GMPI?

A. No - External shifts will not need to be entered prior to the 8 December 2020 updated guidelines release.

Q. When do the new requirements in appendix B commence? A.

Shifts booked through Locum Hub Wales

All shifts booked through Locum Hub Wales will be logged in the system and there is nothing further for the Locum GP to do.

External Shifts

- All External Shifts worked from 1 February 2021 must be logged in LHW
- Shifts worked between 8 December 2020 and 31 January 2021 will sit in a Grace Period and do not need to be entered in LHW
- All shifts in the Grace Period will be eligible for the discretionary GMPI
- To get used to the functionality and form good habits why not start entering your external shifts now

Q. Is there a deadline for entering shifts retrospectively i.e. am I still covered for a shift worked 60 days ago if I enter it now?

A. From 1 February 2021 all shifts arranged outside of Locum Hub Wales will need to be entered in the system before the 28th day after it was worked, they can also be entered in advance. If a shift is entered after the 28th day it will still be accepted in the system but will show as a late entered shift. Where no locum GP shifts are worked the Locum GP must update LHW confirming that no locum shifts have been undertaken within the required reporting period, using the External Shift, Nil return functionality with LHW.

Q. Do we need to enter external shifts for work at Managed Practices?

A. No - Locum Shifts worked in Managed Practices are covered under the Health Board contract and do not fall under The Scheme for General Medical Practice Indemnity (GMPI)

Q. Do we need to enter external shifts for work at OOH locations?

A. No - There is currently no requirement to enter Out of Hours Shifts, if however, you also work Locum Shifts outside of your OOH work these will need to be captured.

Q. How does Shropdoc fit into this/am I covered by Shropdoc?

A. There is no requirement to enter Shropdoc shifts in Locum Hub Wales, if however, you also do Locum Shifts outside of your Shropdoc work these will need to be captured.

Q. Do I need to Log a shift if in a field hospital?

A. No - There is no requirement to enter Field Hospital shifts in Locum Hub Wales, if however, you also do Locum Shifts outside of these locations they will need to be captured.

Q. If a locum shift is not logged accidently, is this a breach of guidelines?

A. Mechanisms exist within LHW that will issue notifications when no shifts have been detected in any one month. Where no locum GP shifts are worked the Locum GP must update LHW confirming that no locum shifts have been undertaken within the required reporting period, using the External Shift, Nil return functionality with LHW.
