

# Would you like to become a Medical Examiner?

Do you want to contribute to making the NHS the safest healthcare system in the world, improving patient safety and reducing harm? Then being a Medical Examiner might be for you.

The Royal College of Pathologists welcomed the Secretary of State's announcement that during 2019 Medical Examiners will begin to independently review all deaths that have not been referred to the coroner.

Following on from the announcement, NHS Wales Shared Services Partnership has been commissioned to establish the service and are recruiting for a national system of Medical Examiners, to improve patient safety and provide support for bereaved families. Medical Examiners will be specially trained, independent senior doctors (from any specialty), who will scrutinise all deaths that do not fall under the Coroner's jurisdiction.

The new service will ensure that every death (starting with hospital deaths) is scrutinised by either a Medical Examiner or a Coroner so that any issues with patient care can be identified quickly, to improve services for others. Medical Examiners will also contact families shortly after they have been bereaved to ensure that any concerns they have about their loved one's care are listened to and considered at the earliest opportunity.

*You can apply to become a medical examiner if you:*

- ▶ Have five years' experience as a fully registered medical practitioner
- ▶ Are currently practising or have retired with recent experience
- ▶ Hold a licence to practise with the GMC

*In addition, you'll need to demonstrate:*

- ▶ Up to date knowledge of medical conditions, treatments and causes of death
- ▶ Knowledge of relevant legislation and processes
- ▶ Knowledge of local and national clinical governance systems
- ▶ Strong communication skills that enable them to deliver their role in a compassionate, professional and discreet manner
- ▶ Ability to work in a multi-disciplinary team

If the role appeals to you and you are eligible to become a Medical Examiner, you will first need to complete mandatory components of an [online e-learning programme](#). Following appointment, you will have three months in which to complete a face-to-face training session and one year to complete the remainder of the e-learning programme.

Croesawodd Coleg Brenhinol y Patholegwyr gyhoeddiad yr Ysgrifennydd Gwladol, a oedd yn datgan y bydd archwilwyr meddygol, yn ystod 2019, yn adolygu'n annibynnol bob marwolaeth sydd heb gael ei chyfeirio at y crwner.

Yn dilyn y cyhoeddiad, comisiynwyd Partneriaeth Cydwasaethau GIG Cymru i sefydlu'r gwasanaeth, ac mae'n recriwtio ar gyfer system genedlaethol o archwilwyr meddygol i wella diogelwch y claf ac i ddarparu cefnogaeth i eu ddechrau. Bydd archwilwyr meddygol yn uwch feddygon annibynnol (o unrhyw arbenigedd) sydd wedi derbyn hyfforddiant arbennig, fydd yn edrych yn ofalus ar bob marwolaeth nad yw'n dod o dan awdurdodaeth y crwner.

Bydd y system newydd yn sicrhau y bydd naill ai archwiliwr meddygol neu grwner yn edrych yn ofalus ar bob marwolaeth (gan ddechrau gyda marwolaethau mewn ysbytai), er mwyn sicrhau y gall problemau gyda gofal y claf gael eu nodi'n gyflym fel bod modd gwella gwasanaethau i bobl eraill. Bydd archwilwyr meddygol hefyd yn cysylltu â theuluoedd yn fuan ar ôl eu profedigaeth i sicrhau bod unrhyw bryderon sydd gan ddynt am ofal eu hanwyliad yn cael eu clywed a'u hystyried cyn gynted â phosibl.
