Title:	Influenza Season 2017-18 – Cessation of use of antivirals now recommended.
What is this about:	This letter advises that GPs should no longer prescribe antiviral medicines empirically for the treatment of influenza-like illness.
Why has it been sent:	For action, information and to pass on to colleagues.

The most recent surveillance data from Public Health Wales indicate that the circulation of influenza viruses in the community has now fallen to baseline levels, and it is unlikely that people presenting with an influenza-like illness have influenza.

General Practitioners and non-medical prescribers should no longer prescribe antiviral medicines (Oseltamivir and Zanamivir) for the empirical prophylaxis and treatment of influenza-like illness in primary care on the NHS.

Hospital clinicians may continue to prescribe antivirals for patients whose illness is strongly suspected, or confirmed, to be due to influenza. For clinicians treating hospitalised patients with antivirals for suspected influenza, rapid laboratory confirmation with subtype identification is advised to support patient management.

This guidance is in line with NICE guidance and subject to GMS contract regulations, commonly known as the Grey List or Selected List Scheme (SLS).

In the event of an outbreak of suspected influenza, GPs and other local prescribers should seek advice from their local Health Protection Team.
