WHTM 01-01 Decontamination of surgical instruments (medical devices) used in acute care Part D: Washer-disinfectors

This Welsh Health Technical Memorandum provides guidance on the whole decontamination cycle in the management and decontamination of surgical instruments used in acute care. Part D covers standards, technical guidance, operational requirements and testing and validation protocols when using washer-disinfectors as part of the decontamination cycle within the acute care setting.

Part D supersedes WHTM 01-01 Part D 2013 edition. It has been updated to take account of recent changes identified within the Advisory Committee on Dangerous Pathogens – Transmissible Spongiform Encephalopathies (ACDP-TSE) Subgroup's Annex C: General principles of decontamination.
